## 378/14 Christmas Lights

Members are advised that the street lighting columns all passes the structural integrity testing and were all therefore deemed safe. The new lighting arrays were installed on High Street near the Halse Road Junction and have been well received. There have been a number of comments relating to the lack of lights on the High Street from the Buckingham Road Traffic Lights past Winchester House School. This is a particularly difficult area to light given the number and size of the trees, but Members could bear this in mind when planning the lights for future years. The location of the Fire Station provides an opportunity to enhance the lighting in that area.
