Purpose of report: To consider the removal of the picnic bench at Jenny's pond

Recommendation: Remove the picnic bench from Jenny's Pond and install it in the

### Main issues and considerations:

This matter was considered some time ago and at that time it was decided not to remove the bench and monitor the situation. Given this is still raising concerns, it has been brought back to members for consideration.

During the past few months we have had reports from residents of late-night gatherings and anti-social behaviour at Jenny's pond. As well as this, the grounds team have noted a large amount of litter constantly being left.

The volunteers from the Wildlife trust who look after the area are concerned the area is being damaged by the current usage and it is felt that removal of the bench will discourage groups congregating in the area.
